SHAPE AMERICA NATIONAL CONVENTION SWEEPSTAKES OFFICIAL RULES

SWEEPSTAKES PERIOD: Individuals meeting the eligibility requirements set forth below may enter the Sweepstakes between 10:01 a.m. (EST) November 13, 2023, and 11:59 p.m. (EST) January 31, 2024 ("Sweepstakes Period").

ELIGIBILITY: By participating, entrants agree to be bound by these official rules ("Official Rules") and the decisions of the Sponsor. **Entries received after the expiration of the Sweepstakes period are not eligible to win.**

To be eligible to win entrant:
